POLICIES AND PARENT STATEMENT OF UNDERSTANDING

I understand that my child won't be allowed to leave the program with an unauthorized person or anyone appearing to be under the influence of drugs or alcohol. I understand that the YMCA is mandated by state law to report any suspected cases of child abuse or neglect to appropriate authorities for investigation. I understand that the YMCA staff are not allowed to baby-sit or transport children at any time outside of the YMCA program.

We (camper and parent) understand that it is the responsibility of each camper to participate in the whole program including activities of work, play, value-sharing, and living together.

We understand and support policies prohibiting campers from possessing and using tobacco products, alcoholic beverages, and nonprescription drugs while at camp. We recognize that campers must follow safety instructions, remain in areas set by staff, and refrain from behavior that is harmful to oneself or others. We understand that the victim defines sexual harassment and bullying, and action will be taken accordingly. Failure to adhere to camp policies will be cause for the camper's dismissal without refund of camper fees.

I am aware that my child will have the opportunity to participate in, and I approve of his/her participating in, camp activities involving a degree of risk, recognizing that the camp will do its best to ensure a safe experience. I understand that accidents may occur. I hereby release the YMCA of Greater Cincinnati from any and all responsibility and liability of any nature resulting from my child's participation in any camp activities.

As parent or guardian, I understand that my child may be photographed and such photographs may be used for future camp promotion. I understand and agree to abide by the restrictions and policies of camp.
